# Virginia Port Authority Board of Commissioners Growth and Operations Committee Electronic Meeting May 18, 2020

The Virginia Port Authority ("VPA") Growth and Operations Committee ("Committee") held an electronic meeting via the Zoom platform on May 18, 2020.

This electronic meeting is assembled during a declared state of emergency when it is impracticable or unsafe to assemble a quorum in a single location to discuss or transact the business statutorily required or necessary to continue operation of the public body in accordance with Item 4-0.01.g of Chapter 1283 of the 2020 Amendments to the 2019 Appropriation Act.

# Motion to Convene an Electronic Meeting

At 2:05 p.m., Chairman McWhorter made a motion to convene an electronic meeting pursuant to the requirements of Item 4-0.01.g of Chapter 1283 of the 2020 Amendments to the 2019 Appropriation Act, to discuss or transact the business statutorily required or necessary to continue operation of the Virginia Port Authority.

At the request of Chairman McWhorter, Mr. Price read the provided the factual basis for convening an electronic meeting:

"It is necessary to convene an electronic meeting today to discuss information that is integral to the continued operations of this Port; specifically, we need to discuss impacts of the COVID-19 virus on the business, operational performance metrics, safety, terminal infrastructure projects and prospective business opportunities. All of these topics are statutorily authorized and required for continued operation of the Port."

Chairman McWhorter affirmed that the motion to convene an electronic meeting carried and was seconded by Commissioner Waters. He asked for a roll call vote of the Growth and Operation Committee members, Chair and Vice Chair of the VPA Board (ex officios), as follows:

# **Opportunity for Public Comment**

Chairman McWhorter asked if there were any members of the public on the conference line who wished to comment. Mr. Angus Cooper spoke on behalf of stevedores and stated that "there were some tough decisions to make ahead" and he wanted the Board members to know that his organization is willing to help in any way they can.

### **Motion for Closed Session**

At 2:05 p.m., Chairman McWhorter read the motion to go into closed session as follows:

"I move that the Growth and Operations Committee convene a closed meeting in accordance with The Virginia Freedom of Information Act, pursuant to the requirements of §2.2-3711(A)(37), and the provisions of §62.1-132.4, to discuss proprietary information and data furnished to the VPA in confidence, including but not limited to customer and cargo contracts, agreements, or information, ship tally sheets, ship manifests, information relating to tonnages and cargoes, annual budgets; as well as metrics, analyses, and data relating to its safety program and terminal throughput activity, including gate, rail, and chassis usage, information technology initiatives, and vessel size and capacity forecasting; and pursuant to §2.2-3711(A)(5), to discuss prospective business or industry or the expansion of an existing business or industry where no previous announcement has been made of the business' or industry's interest in locating or expanding its facilities in the community; and pursuant to §2.2-3711(A)(6), to discuss or consider the investment of public funds relating to strategic growth initiatives and projects, where competition or bargaining is involved, where, if made public initially, the financial interests of the VPA would be adversely affected; and pursuant to §2.2-3711(A)(1), to discuss and consider performance of employees of a public body."

The motion was seconded by Commissioner Waters. Chairman McWhorter asked for a roll-call vote at this time.

At the request of Chairman McWhorter, Ms. McNulty confirmed that the public conference line was disconnected and that the Committee was ready to move into closed session.

### **End of Closed Session**

At 4:38 p.m., the Growth and Operations Committee came out of closed session, Mrs. McNulty announced that the public conference line was connected at this time, and the following resolution was read by Chairman McWhorter:

"Whereas, the Virginia Port Authority Growth and Operations Committee had convened a closed meeting on this date pursuant to an affirmative recorded vote and in accordance with the provisions of The Virginia Freedom of Information Act; and

Whereas, Section 2.2-3712 of the Code of Virginia requires a certification by Committee members that such closed meeting was conducted in conformity with Virginia law;

Now, therefore be it resolved, that the Growth and Operations Committee hereby certifies that, to the best of each member's knowledge, (i) only public business matters lawfully exempted from open meeting requirements by Virginia law were discussed in the closed meeting to which this certification resolution applies, and (ii) only such public business matters as were identified in the motion convening the closed meeting were heard, discussed or considered by the Committee."
