Committee Chair Strayhorn called the meeting to order at 1:32pm.

**Motion for Closed Session**

At 1:33pm, Chair Strayhorn asked for a motion to go into closed session. The motion was read by Committee Vice Chair John C. Asbury as follows:

"I move that the VPA Board's Finance and Audit Committee convene a closed meeting in accordance with The Virginia Freedom of Information Act, pursuant to the requirements of §2.2-3711(A)(37), and the provisions of §62.1-132.4, to discuss proprietary financial data furnished to the VPA in confidence by Virginia International Terminals, LLC ("VIT") and the Hampton Roads Chassis Pool II, LLC ("HRCP II"); and pursuant to §2.2-3711(A)(6) to discuss the consideration of investment of public funds where competition or bargaining is involved.

**End of Closed Session**
